Sociology at Ohio State had another great year. Our faculty members were highly productive, publishing articles in major research journals and garnering grants from NIH, NSF, and other foundations. Vincent Roscigno was awarded 2012 University Distinguished Scholar Award, one of the most prestigious university awards, for his exceptional scholarly accomplishments. In June, we celebrated with Doug Massey, Henry G. Bryant Professor Sociology and Public Affairs of Princeton University, who was conferred the Honorary Degree, Doctor of Social Science during the spring commencement ceremony at Ohio State University. Vinnie's award and Doug's honorary degree recognize their distinguished careers and speak volumes to the kind of work we do as sociologists.

Our graduate students have continued to do well in our program. Job placement was strong among those who were on the market last year (see details as you read further in the newsletter). Qorsho Hassan, one of undergraduate students, was awarded a Fulbright Fellowship and will teach English to high school students in Malaysia this December. Autumn 2012 also marks the beginning of a new major in Department of Sociology – joint with College of Public Health, we now offer a major in Public Health Sociology. More than 40 students have been admitted to this new major.

Dr. Donna Crossman, one of our senior lecturers, retired in June. We are grateful for her many years of contributions to the department and wish her all the best to open another chapter in her life. Meanwhile, we welcome the arrival of Dr. Tim Bartley, Associate Professor, from Indiana University. # **Faculty Newsflash**

**Tim Bartley** has recently become co-editor of the journal Regulation & Governance, an interdisciplinary journal published by Wiley-Blackwell.

Claudia Buchmann's article "The Black Gender Gap in Educational Attainment: Historical Trends and Racial Comparisons" co-authored with Anne McDaniel, Thomas A. DePrete, and Uri Shwed. (2011, *Demography* received the 2011 IPUMS Research Award for best published work using IPUMS data.

**Elizabeth Cooksey** received an award for an R01 from NICHD to collect three more rounds of survey data from the NLSY79 Young Adults over the next five years. Also, Elizabeth will begin a two year term in September 2012 as the President Elect of International Society for Longitudinal and Life course Studies.

**Rachel Dwyer** was one of the three Ohio State faculty members who contributed to the NSF report "Rebuilding the Mosaid" outlining the agency's plans for providing support in the social sciences.

**Doug Downey** is Chair-elect of the Sociology of Education section of the American Sociological Association.

**Reanne Frank** received funding from OSU Office of Diversity and Inclusion to support her project entitled, "The Racial Middle: Racial Identity and Status among Multiracials."

**Angela Harvey** received the 2012 Service Award attesting to the high esteem her colleagues at the OSU Newark campus have for her service contributions.

Dana Haynie's September 2011 article published in the American Sociological Review (Dangerous Liaisons? Dating and Drinking Diffusion in Adolescent Peer Networks with Kreager) garnered much media attention – CNN, Time, and US News and World Report. Melissa Healy of the LA Times described the study as "clever and diabolically complicated". Also, Dana was elected to the Council of the Children and Youth Section of ASA and Chair Elect of Crime, Law, and Deviance Section of ASA.

**Craig Jenkins** co-authored a study with Robert Brulle, Drexel University and Jason Carmichael, McGill University. The new study is on the level of influence national political leaders have on how much Americans worry about the threat of climate change. Their results appeared in the journal *Climate Change*.

Randy Hodson and Rachel Dwyer were awarded a grant from the non-profit foundation, the National Endowment for Financial Education to study youth indebtedness during the transition to adulthood.

**Zhenchao Qian** was quoted in The Columbus Dispatch in February in an article by Randy Ludlow titled Mixed-race marriages grow – and so does acceptance. Also, Qian's recent brief on young adults' living arrangements has been featured in news outlets including USA Today, LA Times, US News and World Report, The Atlantic and Huffington Post.



Vinnie Roscigno was awarded one of only six 2012 University Distinguished Scholar Awards. Recipients of this prestigious award are recognized for exceptional scholarly accomplishments and have compiled a substantial body of research. Also, Vinnie was elected to the ASA Committee on Publications.

**Kammi Schmeer** received two university grants to support her work on food security and child health in Nicaragua. These two grants are the 2012 Engagement Impact Grant and the International Affairs Gateway Research Seed Grant.




## **Our Alumni News**


# Honorary Doctorate Degree Recipient

# Douglas S. Massey

Dr. Douglas Massey, Henry G. Bryant Professor of Sociology and Public Affairs, Princeton University was awarded an honorary degree, Doctor of Social Sciences by President E. Gordon Gee at the spring commencement ceremony on Sunday, June 10, 2012.

On the Friday preceding the commencement ceremony, Professor Massey presented a lecture at the OSU Thompson Library titled "The Paradoxical Originals of Anti-Immigrant Sentiment in America," cosponsored by the Department of Sociology, the Initiative in Population Research and the Innovation Group for the OSU Center for Ethics and Human Values. That event was part of the immigration COMPAS program. The talk was immediately followed by a reception.

Dr. Massey is currently the Henry G. Bryant Professor Sociology and Public Affairs at Princeton University. He has also served on the faculties of the University of Chicago and the University of Pennsylvania. His research focuses on international migration, race and housing, discrimination, education, urban poverty, and Latin America, especially Mexico.



He is the author, most recently, of Brokered Boundaries: Creating Immigrant Identity in Anti-Immigrant Times (Russell Sage Foundation, 2012) and New Faces in New Places: The Changing Geography of American Immigration (Russell Sage Foundation, 2010) among others.

He is a member of the National Academy of Sciences, the American Academy of Arts and Sciences, and the American Philosophical Society. He is currently president of the American Academy of Political and Social Sciences and past-president of the American Sociological Association and the Population Association of America.
